Welcome! This is the PRGC New-Member Packet. Use this to apply for membership in the Paradise Rod & Gun Club of Paradise, California.

Right up front: it will be difficult to impossible to complete this form using a phone. WA-A-Y easier to do it on a computer.

Your objective with regard to this form is to:

1. Fill in the needed information,
2. Get your organic signature onto the relevant pages, and then
3. Get it all in to PRGC in coordination with your new-member dues.

There are a few ways to get this done. **Here are the two super-legible methods:**

METHOD ONE: Fill the form out online, then download it to your own hard drive to save. Then, print it out and sign it where needed.

METHOD TWO: Download it to your hard drive first, then fill it out and save it there. Then, print it out and sign it where needed.

And the one not-so-legible but still legit method:

METHOD THREE: Print the unfilled form straight from the website, fill it in by hand, and sign it.

Whichever method you select, the result will be a signed hardcopy of your application. This, along with your payment, must now get into the hands of the PRGC Membership Chair and Treasurer, respectively. The following methods accommodate payment by check:

- Mail the hardcopy, along with your check, via the USPS to Membership c/o PRGC at P.O. Box 1081, Paradise CA 95967.
- Bring it to a PRGC meeting and pay in person by check (or cash). You can find the dates and times of meetings on our website calendar (http://www.theprgclub.org/PRGC_Calendar.html.)
- Scan your filled, signed membership form into your computer and email it to **membership@ThePRGClub.org**, while separately mailing a check in to PRGC via the USPS.

You are applying for Membership in the Paradise Rod and Gun Club Inc., a private shooting Club. New Members will acknowledge agreement with the following Club Documents and Procedures. Find our club documents on our website: <http://www.The:PRGClub.org> under the **Ranges** menu item.

Membership:

1. Club Membership is a family membership including spouse or partner and children under 18 years of age.
2. You must currently be an NRA member before you are approved to be a Club Member.
3. Members must always be current in Club Membership and NRA Membership.
4. Members must have a current ID Badge and always wear it at the range in a way that keeps it visible.
5. Only the following persons are allowed to discharge guns or archery devices on the PRGC Ranges: Club members and families (defined as spouses or domestic partners and/ or minor children of the Club member's family) as permitted by membership

Range Operations:

1. Follow all safety Procedures when using any Range: Rifle, Pistol, Trap and Archery. Again, find our Range Operations Manual and information on specific ranges on our website under the **Ranges** menu item.
2. Range availability is at the discretion of the Club Safety Manager (CSM). No live firing will take place on any PRGC range without an authorized PRGC RSO (also called the "RSO In Charge" or "RSO I/C") present and on duty at that range.
3. Pay any range fee required before using the ranges.

Release from Liability: Members of any type and all guests shall read and sign the Release From Liability form, once each calendar year, prior to any live fire or any other use of the range. (This form is the next page of this document.)

Alcoholic Beverages and Drugs: Members and guests may not consume alcoholic beverages or drugs before or during live fire. Alcohol is prohibited on the range property.

General: As a concerned Member of the PRGC, I will work towards promoting and encouraging field sports, good fellowship, and sportsmanship. I will uphold the goals consistent with the PRGC and the NRA.

Violation of Club Rules: Any member who violates Safety Rules, Club Bylaws or Range Operations may be subject to disciplinary action.

Membership Fees: One time initiation fee is \$100.00, first year's annual dues are \$50.00, total membership fee for first year is \$150.00.

The applicant must submit copies the following documents, a valid government issued picture ID, current NRA Membership card, this application form, Release from Liability form and Information/Questionnaire form.

The application process includes: payment of fees, submittal of required documents, a review of the application and approval by the Club Executive Board members or approved alternative. Upon approval the new member will be sent an ID Badge within 30 days.

I further expressly acknowledge that I have read the Range Rules and understand my responsibilities while at the range and warrant that I will comply with all Range Rules and the directions of the Range Safety Officers.

With full knowledge, understanding, and awareness of the dangers inherent in the activities occurring on or within the facilities of the Paradise Rod and Gun Club, and in consideration of being granted permission to use the private facilities of the Paradise Rod and Gun Club, I hereby voluntarily assume full responsibility for all risks of any kind whatsoever, whether or not arising from the negligence of Paradise Rod and Gun Club, Inc., its agents, officers, members, employees, successors and assigns (hereinafter referred to in total as PRGC) or myself, and fully release, waive, and forever discharge PRGC, from any and all liability of every kind for any personal injury, property damage, or death suffered by me arising from or by reason of my participation in any activity sponsored by PRGC or arising from or by reason of my use of or presence upon the PRGC facilities.

I further intend that my free and voluntary waiver and release of PRGC be binding upon my spouse, my heirs, executors, successors, and assigns, and that it be interpreted as broad and inclusive as permitted by law. Should any claim, demand, or lawsuit arise or be asserted in any way whatsoever related to my use of, or presence upon, the PRGC's facilities, I shall indemnify, defend, and hold harmless PRGC from any and all costs, expenses, or liability, including, but not limited to, the cost of any settlement or judgment together with all costs of court and other costs or expenses incurred by PRGC in connection therewith, including attorney's fees.

I hereby grant permission to PRGC to administer any first aid or other medical treatment or service that may be necessary in the event of my injury, and do hereby hold PRGC free from any and all liability arising in any manner from any first aid, medical treatment or service rendered me.

I have carefully read this Release and understand its meaning and terms. I execute this Release voluntarily with full knowledge of its significance. Should a court of competent jurisdiction hold any portion of this voluntary release invalid or unenforceable, I intend the remainder to continue in full force and effect.
